3.1.5 Commissions

3.1.5.1 The Vendor agrees to pay Kanawha County Schools a percentage of the proceeds collected by the Vendor from the Vending Equipment placed on Kanawha County Schools' Property, on net collections after any applicable sales tax or deposit. This commission amount shall be remitted by the Vendor to the originating Kanawha County Schools entity within 30 calendar days.

3.1.5.2 The commission percentage will be the amount collected by the Vendor and remitted to Kanawha County Schools which will be the **actual payout** as a percentage of proceeds. This percentage commission, as indicated within the pricing pages, and actual payout amount shall be the net amount remaining after certain adjustments have been made for debts, deductions or other expenses, which includes but is not limited to operating, delivery, taxes and fees pertaining to the distribution and sales of vending products.

Additional Documentation: Documentation related to this Addendum (if any) has been included herewith as Attachment A and is specifically incorporated herein by reference.

Terms and Conditions:

1. All provisions of the Solicitation and other addenda not modified herein shall remain in full force and effect.
