REPORTS

A. Chandler Academy

Amon Gilliam-We have around 40 students at Chandler between the middle and the high school. Students are both a blend of eLearning and in-person. More students are choosing to come back in-person which will increase their chance of success. The school has worked hard on trying to get those students back in person. As far as social, emotional and mental health support, Chandler's counselors and psychologists continue to meet with in-person students on a regular basis to address the needs of students. We continue to hold our partnership with Prestera. They do have a presence in the building and rotate through the student population providing services as needed. They also meet with students for home visits especially for eLearning students. These students are at Chandler primarily for the Prestera support. Some other counseling methods include group and individual counseling which they can complete virtually and also via phone call if needed. In an effort to increase participation and attendance, Chandler uses a variety of methods to contact students and parents when they are not participating academically or attending school when they need to. In regards to the credit recovery program efforts, it has been a difficult year in general. These students are having the same struggles as others in their age group with the additional challenges they may be facing. Chandler has incorporated after-school tutoring, credit recovery tutoring and guidance for students who are failing classes. As those students successfully meet their goals they are exited from the program and more students are added.

Mrs. Jordon-I had a staff person reach out and say they have parents call and would like for their child to attend Chandler because of the rise with anxiety and depression and because of Prestera. Are the rules always going to be written in stone for that? Amon Gilliam-Right now students have to be placed there through the SAT county process or expulsion. That's the process.

Amon Gilliam-I've had parents call and ask and I explain the process and what is needed to be placed at Chandler and what the school that they are at currently can provide and that's where we help them out there.

Dr. Williams-We also have the Collaborative Program at WV State University which for some students may be an alternative as well. Mrs. Jordon-Are we still busting out the seams at the Collaborative? George Aulenbacher.-We have about 40 students there.

Mrs. White-Are the numbers down at Chandler this year? Amon Gilliam-Yes, right now they are.

Mrs. White-Our mother/child program is phenomenal. It's keeping girls in school that probably wouldn't be there. Dr. Williams-This program has been around at least 36 years. The stigma is not like it used to be used to be. It's a good program. It was at Shawnee and that was hard for kids to get to, so when Chandler was redone that's when it was moved.

Mr. Crawford-Two years ago when we visited St. Tammany Parish in New Orleans, they talked about their school that they have for discipline problems. If you don't reach out and find out what other people are doing you won't know. I'd like to see us do that with St. Tammany Parish and give us some new ideas on what we could do with the program at Chandler. It can't hurt our program at all to hear what they are doing. They kept their kids there until there was a change in attitude before they put them back in the general population of the school system.
