Mrs. Tracy White further moved: That the Board approve the Superintendent's recommendation and the following individuals be suspended, without pay, for a period of three days for failing to complete the required Safe Schools Training for two years: Leslie Adams, Joseph Egnor, Francis Gall and Gary Wagner.

Mrs. Tracy White further moved: That the Board approve the Superintendent's recommendation and the following individual be suspended, without pay, for a period of five days for failing to complete the required Safe Schools Training for three years: Chiquita Shelton. Motion was seconded by Mr. Jim J. Crawford.

Mr. Crawford-What do we do after we suspend them for 5 days, is it our policy to go for termination? Dr. Williams-That's one of the options. Mr. Crawford- I think that it is important that we stress our safety. It takes our Worker's Comp down. Our safety program has come a long way.

Mrs. White-I know that it is a long and tedious training but there's absolutely nothing more important than the safety of our kids.

Mr. Cavender-Is there a set amount of time that we give them before termination is considered? Dr. Williams-This one is up to three times that she hasn't done it. Elaine, what is the next step? Elaine Gayton-It is a possible referral for termination. They have from July 1st through December 31st to complete the classes.

The above motion unanimously carried.

QUESTIONS/ANSWERS

Mrs. White-I've received some calls from high school parents asking about prom. Do we have a decision? Dr. Williams-Yes, we just got that information this week and Dr. Aulenbacher met with the high school principals yesterday and they will be having prom this year. Most of the venues will be outside. It will be on three different weekends. They will be announcing that to the kids in the next few days.

Mrs. Jordon-Is it a possibility that graduations will be outside? Dr. Williams-Dr. Aulenbacher met with them today at the Civic Center. Some of the graduations that were going to be held at the Municipal Auditorium are going to be moved to the Civic Center because of the limited seating. That could put a graduation at 3:00 or 4:00 in the afternoon. Last year parents were upset when they were during the day, but I'm thinking if we have them at 3:00 or 4:00 in the afternoon that would be better and then we could have another one at 7:00. We may be changing some of the times and we will let you all know soon. Mrs. Jordon-Laidley wouldn't cost us anything. Dr. Williams-Laidley is reserved just in case. We are playing everything by ear.

Mrs. Jordon-Will there be Project Graduations this year? George Aulenbacher-Yes, but they will be modifying them. They are looking to do as much as they can outside.
